Navsari Agricultural University (NAU) The University at a Glance

Commencing with a college of agriculture established in 1965 on a sprawling farm land of 400 hectares, the Navsari Agricultural University (NAU) of the erstwhile Gujarat Agriculture University has been bestowed with the status of a full-fledged independent State Agriculture University with effect from May 1, 2004. Since then, the NAU has never looked back and has earned name and fame in a very short span of 12 years. In its glorious history of furthering the noble cause of education, research and extension activities in agriculture, NAU has always been the forerunner in academic endeavors by establishing various reputed institutes. NAU can be elicited as a shrine for any educational campus. Within a very short span of time, it has emerged as a high tech education hub with entire spectrum of courses right from Diploma to Doctorate Level.

The NAU Campus is located at Navsari, a district place in the south eastern part of the Gujarat State in the coastal lowland along Purna River. In Navsari, it is located on the historic Dandi March road just 3 kilometers from Navsari Railway Station and 8 km from the NH No. 8. Placed amidst the splendid natural environment, the campus of NAU has neat internal access roads coupled with the architectural delight of the construction of its various buildings including hostels; that imparts the entire landscape a scenic beauty. With the vicinity of all basic facilities, the place provides the most appropriate academic ambience conducive to learning pursuits.

To provide professional manpower and technological backup for the growth and development of agriculture, NAU is imparting agricultural education of Graduation, Post Graduation and Ph. D. level in Agriculture, Horticulture, Forestry, Veterinary, Agribusiness Management, Biotechnology, Agri. Engineering and Fisheries. This University also offers Diploma courses in Agriculture at Waghai, Vyara and Bharuch; Horticulture at Navsari and Paria, Animal Husbandry at Navsari and Agricultural Engineering at Dediapada. Another unique feature of this university is that it imparts vocational education and training to rural youths through Short Term Certificate Courses in Agriculture, Horticulture, Animal Husbandry, Bakery, Landscaping & Gardening, Photography, Turf Grass Management and Fisheries.

NAU undertakes fundamental, applied and verification research in Agriculture, Horticulture, Forestry, Agricultural Engineering and Animal Sciences through respective fully developed faculties, 2 Zonal Research Stations, 3 Main Crop based Research Stations, 3 Regional Research Stations and 6 Verification/Testing Centers.

Strong and effective extension education network has also been built up over the years to cater the transfer of technology to the farmers and agricultural entrepreneurs. The extension component includes 5 Krishi Vigyan Kendras (Waghai, Vyara, Navsari, Dediapada and Surat), Sardar Smruti Kendra (Navsari), Agricultural Technology Information Centre-ATIC (Navsari), Agriculture Educatorium (Navsari), Tribal Women Training Centre (Dediapada), Agro I.T.I (Navsari) and a Training & Visit scheme (Navsari). In fact, the phenomenal growth of farm sector in Gujarat is largely associated with exemplary mode of transfer of technology activities, delivered at the farmers' doorsteps, as well as supply of essential inputs and literature through single window delivery system.

<u>University Central Library</u>: The University Central Library is located in the centre of university campus with adequate infrastructure facilities spread over an area of 22,000 Sq. feet. Class Rooms

MBA (Agribusiness Management)

The MBA (Agribusiness Management) is a two years full time post graduate degree programme, comprising of four semesters. It has been developed to architect Agribusiness students with requisite aptitude and motivation to take up careers in management.

• The Programme specially attempts:

- ✓ To impart knowledge of systematic observation and analytical skills needed to take effective charge of the new agriculture economy.
- ✓ To provide a field based experience to nurture in the students the capabilities of setting standards of excellence in their managerial life.
- ✓ To equip the students with required conceptual and interpersonal skills for solving the practical problems and complexities of the field of agribusiness
- ✓ To develop agribusiness leaders, entrepreneurs and professionals with a vision, competence and attitude for managing agribusiness and agro-based enterprises with a strong business orientation.

Prospects of Agribusiness Management

The programme prepares students for managerial and entrepreneurial careers in enterprises serving or dependent on agriculture and allied sectors such as:

- ✓ Production and Marketing of Inputs such as seeds, fertilizers, pesticides, farm machinery and equipment, livestock feed, irrigation, and credit;
- ✓ Production, Procurement, Processing, and Marketing of Output such as agriculture (includes crops, livestock, fisheries, forestry, agro forestry, horticulture, dairying) marketing, agro processing, and food processing;
- ✓ Providing Services to Agriculture such as export and import, rural banking, financing agri projects, insurance, retail, logistics, water management, research and development, and rural energy.

Ph. D. (Agribusiness Management)

The programme of Doctor of Philosophy in Agribusiness Management - Ph. D. (Agribusiness Management) aims at preparing students to initiate new projects that add to the collective knowledge base of agribusiness field in terms of production, processing, marketing and critical management issues as financing and technical assistance, preparation of products for exports, overseas marketing issues and government policies, etc. The holders of Ph. D. (ABM) may seek careers in teaching, research and extension services of the nonprofit, public and private sectors. The minimum duration of the full time Ph. D. (ABM) programme shall be three years (six semesters).

Admission Procedure

Applications are invited for admission to **Full Time MBA** (**Agribusiness Management**) and **Ph. D.** (**Agribusiness Management**) Programme for the Academic year: 2019-20.

Admission Brochure and Application Form can be downloaded from the University Website www.nau.in. The duly filled application form with required documents along with D.D. of 1000/- (One Thousand Rupees Only) in favour of "DRAWING AND DISBURSING OFFICER (DDO), ASPEE AGRI. MGMT. INST." payable at Navsari should be submitted to The Principal, ASPEE Agribusiness Management Institute, NAU, Navsari on or before 5th August, 2019.

• Intake Capacity:

Total approved intake capacity of MBA (Agribusiness Management) programme is 37 seats (28 NAU Seats + 9 ICAR Seats).

Total approved intake capacity of Ph. D. (Agribusiness Management) programme is 3 NAU Seats.

• Eligibility:

Eligibility for MBA (ABM): Four Year Bachelor Degree from SAUs of Gujarat State / ICAR accredited SAUs of other states in Agriculture and allied sciences viz. Agriculture / Horticulture / Forestry / Veterinary / Fisheries / Agricultural Information Technology / Agricultural Engineering / Dairy Science / Food Science and Technology / Agricultural Biotechnology / Home Science, *etc.* with OGPA of 5.50 out of 10.00 or its equivalent, i.e., 55% (relaxed to 50% or 5.0 out of 10.00 for SC / ST / SEBC).

<u>Eligibility for Ph. D. (ABM)</u>: Master's degree in Agribusiness / Agribusiness Management subject from SAUs of Gujarat State / ICAR accredited SAUs of other states with OGPA of 6.50 out of 10.00 or its equivalent, i.e., 65% (relaxed to 60% or 6.0 out of 10.00 for SC / ST / SEBC).

• Selection Procedure:

After scrutiny of the duly filled Application Forms received before the last date, the list of eligible candidates will be displayed on the University Website www.nau.in. No individual call letters will be issued. The eligible candidates seeking admission to MBA (Agribusiness Management) or Ph. D. (Agribusiness Management) are required to appear in the Entrance Test to be held at NAU, Navsari; at their own cost.

The merit list for admission to MBA (Agribusiness Management) and Ph. D. (Agribusiness Management) shall be prepared by giving 50:50 weightage to the OGPA (percentage marks) of the last degree and marks obtained in the Entrance Test. Additionally the marks of sports/cultural activities shall also be added before preparing the merit list.

Note: The benefit of the highest level of the above weightage shall be given to the student only once during university career.

Separate merit lists will be prepared as follows:

- (1) Domicile of Gujarat and pass out from SAUs of Gujarat State / ICAR accredited SAUs of other states
- (2) Non domicile of Gujarat and pass out of SAUs of Gujarat State

All the post graduate seats (except ICAR Quota) may be filled up from the students of domicile of Gujarat; but if seats remain vacant from students of Gujarat origin, such vacant seats may be filled up by the candidates of other states who passed their degree from SAUs of Gujarat State. However, candidate pass out from Private Universities/Colleges not approved by State Government and not accredited by ICAR will not be considered eligible even for entrance test to be conducted for admission to MBA (Agribusiness Management) and Ph. D. (Agribusiness Management) programmes.

Entrance Test:

Entrance Test will be of One Hour duration and Total 100 marks for both the programmes. Each question will be of 1 mark. There will be no negative marking for the wrong answer. Final qualifying cut-off for the entrance test will be decided by the Admission Committee of the University. The candidates are instructed to bring Black Ball Point Pen for marking answer on the OMR Answer Sheet.

Entrance Test Pattern for MBA (ABM): Multiple choice questions from the sections of Basics of Agriculture and allied sciences, Verbal Ability, Logical Reasoning, Quantitative Aptitude, Data Interpretation and General Knowledge will be included.

Entrance Test Pattern for Ph. D. (ABM): Multiple choice questions from the subjects of post graduation will be included.

• Reservation of Seats:

General Conditions regarding Reservation: A candidate availing benefit of seats earmarked for the categories shall be required to produce the certificate of belonging to a particular group i.e. SC/ST/SEBC/EWS from competent authority of Gujarat State. The candidates belonging to SEBC should produce the "Non creamy layer certificate" for Gujarat domicile in the prescribed format issued by the competent authority of the Gujarat State with validity as per Government Resolution No. SSP/122015/455246/A Dt. 26/04/2016 issued by Department of Social Justice & Empowerment, Government of Gujarat, Gandhinagar and candidates belonging to EWS should produce the "Economically Weaker Section certificate" in the prescribed format issued by the competent authority with validity as per Government Resolution No. EWS/122019/45903/A Dt. 25/1/2019 of Dept. of Social Justice & Empowerment, Govt. of Gujarat, Gandhinagar.

Reservation of seats shall be as per the roster prescribed by Government of Gujarat from time -to- time.

If the need arises on account of vacant seats due to less number of applications in one group and shortage of seats due to more number of application of eligible candidates in the other group, reciprocal adjustment in the above specified SC (7%) and ST (15%) seats between the two groups will be made. If applications from backward class candidates are more than the reserved seats earmarked for them as above, admission will be given to them strictly on *inter se* merit within each of the only two groups.

Reservation for Candidates nominated by ICAR: Twenty five percent of the total number of seats earmarked for out state candidates shall be reserved for the candidates nominated by the Indian Council of Agricultural Research (for post graduate courses on the basis of ICAR AIEEA (PG) 2019, subject to the condition that they fulfill the minimum requirement of SAUs of Gujarat State for admission).

<u>Reservation for Differently abled (Physically Challenged) Candidates</u>: Five percent seats, reserved for the differently abled (physically challenged) candidates are adjustable within the respective category.

The conditions are:

- (1) A candidate, having locomotors disability of one leg and partial arm, shall be eligible to apply for admission to a course, subject to the submission of a certificate to that effect from the Civil Surgeon / Medical Superintendent of the Government Hospital based on the opinion of the concerned specialist, that the locomotors disabled candidate is in a position to undertake the course and perform the functions of the concerned field. The admissions will be on the basis of *inter se* merit only.
- (2) Differently abled (physically challenged) candidate shall have to fulfill the academic and minimum requirements of marks at the qualifying examination of category.

Candidates shall not be admitted to Post Graduate Programme of any discipline, if he or she suffers the following disabilities, namely:-

- a) Disability of total body including disability of chest or spine more than 50%,
- b) Disability of lower limb of more than 50%,
- c) Disability of upper limb,
- d) Visually handicapped candidates and those with hearing disability.
- e) Candidates with progressive diseases like myopathies, etc.
- f) Disabilities which otherwise would interfere in the practical during study period.

- (3) Original Certificate / Mark sheet / Documents should not be sent. However Original Certificate / Mark Sheet / Documents will have to be produced at the time of admission / counseling and payment of fees.
- (4) Student from any other University shall be disqualified for admission to the Post Graduate study, if Migration Certificate is not submitted within one month after admission.
- (5) Student coming from other University will have to obtain the Eligibility Certificate from Navsari Agricultural University on payment of prescribed fees, within one month after admission.
- (6) A candidate admitted to the Post Graduate programme will have to apply separately for Hostel Admission at the time of joining the college.
