


Request for amendment in rules and regulations for use of sports places of the Navsari Agricultural University

## APPENDIX - A

### RULES FOR USE OF SPORTS PLACES – 2022

#### NAVSARI AGRICULTURAL UNIVERSITY

#### 1.0 Title and Commencement

These rules may be called "**Rules for Use of Sports Places - 2022**" and they shall come into force for one year with effect from such date as may be specified by the Board.

#### 2.0 Definitions

In these rules –

- (a) "**Authority-in-charge**" in relation to any sports place means the authority in charge of such place. *i.e.* Director of Students' Welfare, Navsari Agricultural University, Navsari for the main university campus and Head of the Office for sub-center where such facilities are available.
- (b) "**Sports place**" includes a swimming pool, badminton court (indoor), tennis court, table-tennis hall, hockey ground, football ground, cricket ground, basketball court, volleyball court and any other sports ground belonging to the University

#### 3.0 Use of Sports Place by other institutions/organizations

Where any Sports place is required by a government institute, semi-government institute, private parties, co-operative, NGOs or a recognized Sports organization for holding any sports competition the authority in charge may permit the use of such place for competition

#### 4.0 Application for the use of place

The institution or, as the case may be the organization so requiring any sports place shall at least ten days before the date fixed for competition, make an application in writing to the authority-in-charge for permission to use the sports place for holding the competition stated in the application.


**5.0 Deposit and maintenance charges to be paid for the use of sports places**

The applicant shall pay the deposit and the maintenance charges along with application to the authority-in-charge as follows:

## **6.0 Permission to use Sports Place**

On receipt of the application under Rule-4, along with the requisite deposit and the maintenance charges, the authority-in-charge may grant permission to the applicant to use the sport place based on availability.

## **7.0 Other condition governing the use of Sport Places**

- 7.1 A permission granted to use a sports place shall not be transferable and shall be subject to the other conditions here in after specified.
- 7.2 Permission for the use of sports place shall not be granted for any political activity/ /group discussion etc. which may cause harm to the public tranquility or for debate on the policy/affairs of state/country/ international policy.
- 7.3 The person holding the permission (hereinafter referred to as "the permit holder") shall be solely responsible to obtain in time, the licenses and permits, if any, required under Rules and to meet the other requirements of law.
- 7.4 The permit-holder while taking possession of the sport place shall check up the chairs, fans, curtains, bulbs and other furniture and fixtures installed in the sport place and shall make a report in writing to the authority-in-charge stating that the things are in order.
- 7.5 The possession of the sport place shall be immediately handed over back to the authority-in-charge by the permit holder on expiry of the permission period. While handing over the possession of sports place the furniture and fixtures installed, there in shall be handed over in the same condition in which the possession thereof was taken. If there be any damage to or breakage of any article in the sports place, the cost thereof shall be recovered from the amount deposited by the permit holder. In case the amount of deposit is inadequate for such recovery, the permit holder shall make payment of the balance amount without delay. The balance amount of the deposit, if any, after deducting the amounts as aforesaid will be returned to the permit-holder.
- 7.6 The permit holder shall take proper care in keeping the sport place clean.
- 7.7 If the permission granted to the permit holder is in any way transferred to any other person, the permission shall be withdrawn and the entire amount of the deposit and maintenance charges shall be forfeited and credited to the University Fund.
- 7.8 No hawkers shall be allowed on the premises without the permission of the authority-in-charge.

## **8.0 Cancellation of Permission**

**8.1** The date and timing once approved for use of the sports place may be changed in genuine circumstances. In the event of cancellation of reservations once made, the deposit will be refunded if the sport place is not used.

**8.2** At any time before the possession of a sports place is taken by the permit holder by virtue of permission granted to him, it shall be open to the Director of Students' Welfare/Vice-Chancellor to cancel the permission without giving any reason (s). In such cases, the deposit and the charges paid shall be refunded to the permit holder without any other compensation.

## **9.0 Disruption or Discontinuation of Programme**

If on account of any unavoidable circumstances or accidents or misconduct of persons occupying the sport place, the Programme/function arranged is disrupted or is discontinued, the University shall not be liable to refund to the permit holder, the amount paid by him to the University by way of charges for the use of sport or to pay any compensation in this regard.

## **10 Right of University Staff to enter the Sport Place**

The members of the staff engaged in the management of the sport place shall have the right to enter the sport place and perform their duties without any restrictions/interruptions.
