## Appendix - A

Regulations for awarding "Matrushree Sukhiben Lallubhai Patel Gold Medal" to the student obtaining the highest OGPA in the Agronomy (Thesis work in Weed Management) at Post Graduate level in the Faculty of Agriculture, Navsari Agricultural University, Navsari.

- 1. The regulations for the award of "Matrushree Sukhiben Lallubhai Patel Gold Medal" are framed under Statute 47 of the Navsari Agricultural University.
- 2. The Medal Shall be known as "Matrushree Sukhiben Lallubhai Patel Gold Medal".
- 3. The annual realization of the total endowment of Rs. 3,00,000/- (Rupees Three Lakh only) shall be credited to the general fund of Navsari Agricultural University to award the gold medal.
- 4. The amount of endowment shall be suitably invested by Navsari Agricultural University in the form of fixed deposit in any Nationalized bank.
- 5. The Gold medal shall be awarded to the student who stood **FIRST** on the basis of Overall Grade Point Average (OGPA) in the subject of Agronomy at Postgraduate degree examination and the quality of research work presented in the thesis submitted to Navsari Agricultural University in Agriculture faculty.

A committee shall consider the cases of those students who conduct the P.G. research on weed management in agriculture faculty of Navsari Agricultural University. The top five candidates who have thesis research work in weed management and secured OGPA 7.00/10.00 and above shall be screened for this Medal. The recipient shall be decided by the Committee on the basis of 40 and 60 percent weightage of course work and research contribution, respectively.

- 6. In the event of tie, the recipient of medal shall be decided on the basis of the highest OGPA obtained in the concerned compulsory subjects as the case may be. Even if, the tie continues the candidate having the highest OGPA in the minor subjects will be considered.
- 7. A committee consisting of (a) Dean, PG studies (b) Dean, Agriculture faculty (c) Director of Student's Welfare (d) Registrar of Navsari Agricultural University and (e) One expert nominated by Hon. Vice Chancellor shall decide the awardee for the Gold Medal and the decision of the committee shall be final.
- 8. The medal shall be awarded in the form of Gold Medal engraved with the words "Matrushree Sukhiben Lallubhai Patel Gold Medal"
- 9. The Medal shall be awarded to the student on the occasion of Annual Convocation every year.
- 10. The endowment shall suitably be acknowledged by the Navsari Agricultural University on the occasion of the Annual Convocation and also be incorporated in the Annual Report of the University
- 11. A student who secured **'F'** (Fail) or **'US'** or **'I'** grade at any time in any subject or had at any time **dropped** (barring withdrawal) the course as a regular student shall not be eligible for the medal.
- 12. The students who awarded 'CP' (Conduct Probation) at any stage of entire study programme shall not be eligible for the medal.
