महोदय/Madam/Sir,

1. Fruit flies are responsible for huge losses in perishable produces India as well as major constraint in export of fruits and vegetables. Many importing countries stipulate stringent phytosanitary treatments and at times impose prohibition on import of fruits and vegetables from India. Timely management of fruit flies in the field by using para-pheromones minimizes the input cost and at the same time avoids damage due to fruit fly infestations.
2. NIPHM is popularizing the adoption of low-cost fruit fly traps and lures for management of fruit fly and also emphasizing on proper monitoring and surveillance of domestic and exotic fruit flies. In this regard NIPHM is organizing 5-days online/virtual training programme on "Fruit fly: Surveillance and Management" from 21.09.2020 to 25.09.2020.
3. The training will be focussing on *identification of different fruit fly species that are damaging fruits and vegetables, role of para-pheromones in trapping and monitoring, preparation of low cost traps and lures, management of fruit flies, Sanitary and Phytosanitary (SPS) measures for the pest.*
4. There is no course fee for officers nominated by your organization and the program is offered under CISCO-WEBEX MEETING platform.
5. You are requested to send nomination of 3 to 5 officers from your department/organization.
