


Regulations for the Award of "ASPEE Foundation Gold Medals" for the graduate and post students of Horticulture and Forestry faculties.

## Appendix-C

### Regulations for the Award of, "ASPEE Foundation Gold Medal" for the student who obtained the highest OGPA in M. Sc. (Horticulture) in the subject of Fruit Science or Vegetable Science.

1. The regulations are formulated under Statute-38 of the Navsari Agricultural University.
2. The medal shall be known as **"ASPEE Foundation Gold Medal"**.
3. The annual realization of the total endowment of Rs. 10,00,000/- (Rs. Ten Lacs only) shall be credited to the general fund of the Navsari Agricultural University to award six gold medals. (Above mentioned gold medal is one of six).
4. The amount of endowment shall be suitably invested by the Navsari Agricultural University in the form of fixed deposit in any Nationalized/ commercial bank.
5. The Gold Medal shall be awarded to a student who obtains the highest Overall Grade Point Average (OGPA) in M. Sc. (Horticulture) in the subjects of Fruit Science or Vegetable Science degree examination and the quality of research work presented in thesis. A committee shall consider the cases of those students who conducted the research on respective subjects of Navsari Agricultural University. The candidate having minimum 7.0 out of 10.0 OGPA will be eligible. The recipient should be decided by the committee on the basis of 35 and 65 per cent of course work and research contribution, respectively.  
In the event of a tie, the awardee shall be selected on the basis of the highest OGPA obtained in the compulsory subjects of Fruit Science or Vegetable Science as the case may be. Even if the tie continues the candidate having the highest Grade Point obtained in the minor subjects will be selected for award.
6. The prize shall be awarded in the form of a Gold Medal engraved with the words **"ASPEE Foundation Gold Medal"**.
7. A committee consisting of (a) Dean PG studies, (b) Dean, Faculty of Horticulture, (c) The Director of Student Welfare, (d) Registrar, Navsari Agricultural University and (e) One expert nominated by Hon. Vice Chancellor shall decide the awardee for the Gold Medal and the decision of the committee shall be final.
8. The Gold Medal shall be awarded to a student on the occasion of the Annual Convocation.
9. The endowment shall suitably be acknowledged by the Navsari Agricultural University on the occasion of the Annual Convocation.
10. The endowment shall suitably be incorporated in the annual report of the Navsari Agricultural University.
11. A student shall not be eligible for the award of Gold Medal if he/she (i) Secures less than 5.0 grade point or secures 'F' (Fail) or 'US' (Unsatisfactory) or 'I' (Incomplete) grade at any time in any subject, (ii) has dropped (Barring withdrawal) any subject as regular student, (iii) left the subject incomplete or (iv) was punished under the 'Discipline Rules' by the College or placed under Conduct Probation by the college authority, or punished for use of "Unfair means" in the examination of Navsari Agricultural University till the end of final year examination.
