Appendix - A

Regulations for the Award of, " Gulabbhai Mehta Gold Medal, sponsored by Sahakari Khand Udhog Mandal Ltd., Gandevi" for the student of M. Sc. (Agri.) or Ph. D. who contribute the research in sugarcane of any subject in the Navsari Agricultural University

1. The regulations are formulated under Statute-38 of the Navsari Agricultural University.
2. The medal shall be known as **"Gulabbhai Mehta Gold Medal, sponsored by Sahakari Khand Udhog Mandal Ltd., Gandevi"**
3. The annual realization of the endowment shall be credited to the general fund of the Navsari Agricultural University.
4. The amount of endowment of Rs. 2,00,000/- shall be suitably invested by the Navsari Agricultural University in the form of fixed deposit in any Nationalized/ commercial bank.
5. The Gold Medal shall be awarded to a student who obtains the highest Cumulative Grade Point Average (CGPA) in M. Sc. (Agri.) or Ph. D examination and the quality of research work presented in thesis. A committee shall consider the cases of those students who contribute the research in sugarcane of any subject offered by the Navsari Agricultural University. In case such number of students are more than One the list be prepared by the Registrar office and should be sent along with thesis's to Director of Student Welfare for further necessary action.

The candidate having minimum 7.0 out of 10.0 OGPA will be eligible. The recipient should be decided by the committee on the basis of 35 and 65 per cent of course work and research contribution, respectively. The weightage will be given to Ph. D. candidate and if Ph. D. candidate is not available then M. SC. (Agri.) will be considered for this medal.

6. The medal shall be awarded in the form of a Gold Medal engraved with the words "Gulabbhai Mehta Gold Medal, sponsored by Sahakari Khand Udhog Mandal Ltd., Gandevi"
7. A committee consisting of (a) Dean PG studies, (b) Dean, Faculty of Agriculture, (c) The Director of Student Welfare, (d) Registrar, Navsari Agricultural University and (e) One expert nominated by Hon. Vice Chancellor shall decide the awardee for the Gold Medal and the decision of the committee shall be final.
8. The Gold Medal shall be awarded to a student on the occasion of the Annual Convocation.
9. The endowment shall suitably be acknowledged by the Navsari Agricultural University on the occasion of the Annual Convocation.
10. The endowment shall suitably be incorporated in the annual report of the Navsari Agricultural University.
11. A student shall not be eligible for the award of Gold Medal if he/she (i) Secures less than 6.0 grade point or secures 'F' (Fail) or 'US' (Unsatisfactory) or 'I' (Incomplete) grade at any time in any subject, (ii) has dropped (Barring withdrawal) from any subject as regular student, (iii) left the subject incomplete or (iv) was punished under the 'Discipline Rules' by the College or placed under Conduct Probation by the college authority, Navsari Agricultural University or punished for use of "Unfair means" in the examination of Navsari Agricultural University till the end of final year examination.
