**Time Deadlines:** Last date of receiving applications / nominations **29 March, 2025** for both the awards.

**1. NAU Life Time Achievement**

**Eligibility:** Retired faculty of NAU who had contributed notably in teaching/research/ extension of agriculture and allied sciences during his/her service at NAU.

**Award:** One award (Citation)

**No. of award:** One annually

**Selection of candidate:**

- Name of candidate can be proposed by any current faculty of the NAU or other SAUs of Gujarat.
- In case of self-nomination, the application should be certified by the Head of the Institute where she/he worked and retired.
- Nominations should be addressed to the Registrar of NAU.
- Selection of the Awardee shall be made by a five-member committee of experts, constituted by the Vice Chancellor.

**A statement of significant contributions and achievements.**

(a) Awards /Honors / Certificate of Appreciations and Recognition received if any? (Give the name(s) of the awards received chronologically along with the awarding Organization / Learned Body and the achievements for which they were given).

(b) Evidences of demonstrated leadership.

- The submissions for their recognition are considered in confidence by the committee and the nomination will not be publicity disclosed by RTI.
- If no candidate is considered for the award, it may be kept vacant. The decision of university shall be final in this regard.

**Application should include:**

- a. A statement of significant contributions in teaching/research/extension limited to five typed pages duly signed by the nominee should be sent. Specific verifiable references may be made about student success, research papers published and patents awarded or other success.
- b. Evidence of demonstrated leadership

## 2. NAU-ratna (Outstanding alumnus)

This award is to appreciate the contribution of NAU alumnus who has contributed significantly in his/her chosen field for more than 10 years. The award aims to form a strong linkage with our alumni.

### **Eligibility:**

- Alumnus of NAU who had contributed notably in his/her chosen field for more than 10 years and has genuine achievements.
- *Alumni who is present or past employee of NAU, shall not be considered for the award.*

**Award:** One award (Certificate and plaque)

### **Selection of candidate:**

- Name of candidate shall be proposed by university officers of the NAU with a brief description of his/her achievements and brief biography.
- Nominations should be addressed to the Director of Research and Dean, Post Graduate Studies of NAU.
- Selection of the awardee shall be made by a five-member committee of faculty members, constituted by the Vice Chancellor.
- The Expert committee unanimously select the NAU-ratna awardee.

### **Judging criteria:**

- **Impact:** Evidence of tangible impact, and scale of impact, of alumni work in the profession/community/society.
- **Influence:** Evidence of how his/her education at NAU has played a key influence in his/her success.
- **Media traction:** Extent to which his/her award is likely to resonate with local/regional /national media.
- **Potential to influence and inspire:** Extent to which his/her story are likely to influence and inspire the next generation of NAU students.
