**MoU FOR R & D FOR EVALUATION OF TRANSGENICS/ VARIETIES/ HYBRIDS  
AND AGRO PRODUCTS/ OTHER PRODUCTS  
IN SAUs OF GUJARAT  
TERMS AND CONDITIONS**

- 1) The transgenic trials will be conducted only for varieties/hybrids approved/modified by GEAC/RCGM. In case of new events, if any, permission from Licensers Company and competent authority has to be produced. If the company fails to submit permit, the trial will not be conducted and the amount forfeited.
- 2) The consent for conduct of the trial along with permit(s) should reach to the Director of Research latest by **1<sup>st</sup> May** and seed material by **15<sup>th</sup> May**.
- 3) All the entries will be coded before sowing and evaluated with other entries with common checks.
- 4) The number of entries should not be more than three per event, per species group of a company, exceeding which will be treated as separate trial. The total number of entries of a company per crop will be restricted to six only, in maximum three trials.
- 5) H x B entries will be evaluated in separate trial.
- 6) In case of Bt varietal evaluation, conventional non Bt and Bt checks will be taken as laid out by DBT/ ICAR.
- 7) The material to be evaluated along with checks shall have to be supplied by the concerned company.
- 8) The total number of treatments (in case of agronomy/ entomology/ physiology evaluation) per trial should not exceed 8 with 3/4 replications. If the number of treatments exceeds 8, each additional treatment but not exceeding 12 (twelve) will be charged @ ₹ 20,000/- + overhead charges, as applicable.
- 9) Fibre quality will be analysed on chargeable bases by **CIRCOT**. Remittance for the same shall have to be made in the name of "**Director, CIRCOT**", payable at **Mumbai** and sent to **Scientist in Charge, CIRCOT, Athwa Farm, Surat-395 007** under intimation to **Research Scientist (Cotton), Surat**.
- 10) The university will have full right to publish or otherwise utilize the data for research purpose.
- 11) The total testing charges for one year/ trial/ location for the current season will be ₹ 4,84,000/- as per details given here under. The charges will remain same for second year for the same trial.


