In view of the directions of the Hon'ble Supreme Court to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy on in disciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment of embarrassment to so as to adversely affect the physique or psyche of such fresher or any student, with or without an intent or derive a sadistic please or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institution and psychologically, of all students, the ASPEE AGRIBUSINESS MANAGEMENT INSTITUTE, in consultation with the university, brings forth this Regulation.

The ASPEE AGRIBUSINESS MANAGEMENT INSTITUTE, Navsari is pleased to form the Committee at college level with reference to the judgment of Hon'ble Supreme Court dated 8th May, 2009 for prevention of ragging in the colleges.

Functions of the college level Anti Ragging Committee

1. To hold orientation programmes for students.

To hold joint sensitization programme and counseling of both fresher's and senior by a professional counselor.

3. To hold joint orientation programmes of fresher's and seniors to addressed by

the Principal and the anti ragging committee.

4. Send periodic reports of the action taken report to the university.

5. The principal shall obtain an undertaking from every teaching and non-

ragging which comes to his/her notice.

 The college canteens and hostel messes are also places where ragging often take place. The employers/employees of the canteens/mess shall be given necessary instructions to keep strict vigil and to report the incidents of ragging

to the college authorities if any.

7. Each batch of fresher's should be divided into small groups and each such group shall be assigned to a member of the staff. Such staff member should interact individually with, each member of the group once in week for ascertaining the problems/difficulties if any faced by the in the extending necessary help. By building up rapport with each member of the group teachers or other members of the staff would be able to infuse confidence in the fresher's and make them feel at home so as to enable them to report incidents of ragging or bullying. Each group in charge shall maintain a diary of his/her interaction with the fresher's under his/her charge.

8. In the case of fresher's admitted of a hostel it shall be the responsibility of the teacher in charge of the group to coordinate with the warden of the hostel and to make surprise visits to the rooms in the hostel where the members of the

group lodges.

9. Freshers shall be lodged in a separate hostel block, wherever possible and where such facilities are not available, the college shall ensure that senior's access to fresher's accommodation is strictly monitored by wardens, security

quards and college staff.

10. If any incident of ragging comes to the notice of the authority concerned. The accused student will be given opportunity to explain and if his explanation is not satisfactory the authority would expel him from the college and if found guilty he/she should be expelled from the university.

11. Any other appropriate steps for prevention of ragging.

Anti-ragging squad: The anti-ragging squad shall have the following members:

1. Hostel rector

2. Student's Representative Boys (senior) of the college

3. Student's Representative Girls (senior) of the college

4. Student's Representative Boys (Fresher) of the college
