- The quoted price must be inclusive of all applicable taxes.
- The quotation shall remain valid for a period of 120 days from the date of submission.
- The envelope should be clearly marked with "Quotation for Antibiotic Standards & Chemicals," and the sender's name, address, and contact number must be prominently mentioned.
- No correspondence or communication shall be entertained after the submission of quotations.
- No advance payment will be made. Payment will be processed only after the satisfactory supply and acceptance of the standards and chemicals.
- Supply of chemicals and standards must be from internationally reputed manufacturers such as Merck life science/Dr. Ehrenstorfer, or equivalent, holding valid ISO certification, specifically ISO/IEC 17034 or an equivalent internationally recognized quality standard. Proof of certification must be submitted with the quotation.
- Supplied chemicals must not have a short expiry and should possess a minimum shelf life of one year from the date of receipt.
- Any discounts offered must be clearly specified in the quotation.
- Authorized dealers must enclose an attested photocopy of the authorization certificate from the manufacturing company.
