ANNEXURE I [Appendix 51.29(i)]

Regulations for the Award of "Dr. A. H. Shah Excellence Gold Medal" for the student who stands first in evaluation based on overall Grade Point Average (OGPA) and the quality of research work at the Master level in Agriculture faculty.

- 1. The medal shall be known as "Dr. A. H. Shah Excellence Gold Medal".
- 2. The annual realization of the total endowment of Rs. 5,15,000/- (Rs. Five Lakhs Fifteen Thousands only) sponsored by post graduate students and well-wishers of Dr. A. H. Shah shall be credited to the general fund of the Navsari Agricultural University to award this gold medal.
- 3. The amount of endowment shall be suitably invested by the Navsari Agricultural University in the form of a fixed deposit in any Nationalized/commercial bank. The 100g Silver Medal plated with Gold should be prepared from the annual interest obtained from the deposit and should be awarded at the annual convocation function.
- 4. The prize shall be awarded in the form of a Medal engraved with the words "Dr. A. H. Shah Excellence Gold Medal".
- 5. The Medal shall be awarded to a student who stands first in evaluation based on Overall Grade Point Average (OGPA) and the quality of research work presented in the thesis at master level in Agriculture faculty. The recipient should be decided by the committee based on 35 and 65 percent of course work and research contribution, respectively.
 - In the event of a tie, the awardee should be selected based on the highest OGPA.
- 6. Dean of Agriculture faculty shall submit the list of candidates consist of top ten students from total M.Sc. (Agri.) subjects based on OGPA to the Experts' Committee.
- 7. A Experts' committee consisting of (a) Dr. Z. P. Patel (Chairman), (b) Director of Research and Dean PG studies, (c) Dean, Faculty of Agriculture (Member Secretary), (d) Registrar, Navsari Agricultural University and (e) One expert

and

nominated by Hon. Vice Chancellor shall decide the awardee for the Gold Medal and the decision of the committee shall be final.

- **8.** The Medal shall be awarded to a student on the occasion of the Annual Convocation.
- 9. The endowment shall suitably be acknowledged by the Navsari Agricultural University on the occasion of the Annual Convocation.
- **10.** The endowment shall suitably be incorporated in the annual report of the Navsari Agricultural University.
- 11. A student shall not be eligible for the award of the Gold Medal if he/she (i) Secures less than 7.5 grade point or secures 'F' (Fail) or 'US' (Unsatisfactory) or 'I' (Incomplete) grade at any time in any subject, (ii) has dropped (Barring withdrawal) any subject as a regular student, (iii) left the subject incomplete or (iv) was punished under the 'Discipline Rules' by the College or placed under Conduct Probation by the college authority, or punished for use of "Unfair means" in the examination of Navsari Agricultural University till the end of final year examination.
