Standard Operating Procedure (SOP) / Guidelines to be followed by the students, permitted to stay in the Hostel

All the UG/PG students of the Navsari Agricultural University are informed that they have to strictly adhere to the following instructions to prevent the spread of pandemic Novel Coronavirus (COVID -19).

- 1. It is compulsory to submit the duly signed (both, parent and student) prescribed undertaking form.
- 2. Permitted students must abide to follow the guidelines pertaining to precautions to be taken by individual(s) to prevent the spread of virus as declared by the Government and the University from time to time.
- 3. Students coming from COVID -19 contaminant zone will not be permitted in the Hostel in any circumstances. Any deceptive / misleading information in this regard, is a violation of Epidemic Diseases Act, 1897(Any person disobeying any regulation or order made under this Act shall be deemed to have committed an offence punishable under section 188 of the Indian Penal Code (45 of 1860).

With reference to COVID-19, the guidelines issued by Government and University authorities are summarized as below:

- a. It is compulsory to download "Aarogya Setu" mobile app. (NIC e Gov Mobile apps) in the mobile and should be updated at regular intervals.
- b. It is mandatory to use face mask and maintain social distance at least 2.0 meter between the individuals, especially while working in farm, office and laboratory as well as in the Hostel premises.
- c. Must wash the hands with soap / sanitize frequently while working in office, farm and laboratory.
- d. Each student must have soap / sanitizer in the hostel for maintaining hygiene at two-hours interval especially before lunch, dinner and break-fast.
- e. Avoid unnecessary physical contact with metals like door/window handles, staircase, grills, water cooler, laboratory equipments, office furniture etc.
- f. To check body temperature thermometers are made available with the hostel care taker, in case of any symptoms of sickness, sneezing and fever one must inform care-taker / Hostel Rector immediately.
- g. Every student must keep / wear College "Identity card" all the time.
- h. Spitting and throwing of waste in the University premises is a punishable offence.
- i. Student must keep themselves himself updated with recent guidelines from the Government and University.

- j. Student must not leave the University campus unnecessarily, without prior permission from the Hostel management / assistant rector of the concerned Hostel.
- k. Student should avoid gathering / interacting in close groups in the Hostel as well as University premises.
- 1. Visitors from outsiders are not permitted in his / her hostel room.
- m. Food facility will be provided by the Hostel Management; however, students should have their own dish, glass, spoon etc.
- n. During lunch/dinner time, student will have to collect the food from mess counter. Thereafter, students should eat their meal in their own rooms only. In any circumstances, lunch/dinner will not be allowed in the dining hall. All students must maintain cleanliness after having lunch/dinner in the hostel premises.
- o. It is our moral responsibility to cooperate in the fight against COVID 19, while protecting our life and doing our duties.

Important: If any student is found to violate the above-mentioned guidelines, it will be considered as violation of Epidemic Diseases Act, 1897. In such condition, he/she will be expelled from the University or punished, as decided by the University authority.
