Annexure - I

Regulations for the Award of "Dr. D. H. Chavda Gold Medal" for the undergraduate student who obtained the highest marks in Genetics and Plant breeding subjects of Agriculture faculty

- 1: The medal shall be known as "Dr. D. H. Chavda Gold Medal".
- 2. The annual realization of the total endowment of Rs. 5,000/- (Rs. Five Thousand only) shall be credited to the general fund of the Navsari Agricultural University to award this medal.
- 3. The amount of endowment shall be suitably invested by the Navsari Agricultural University in the form of a fixed deposit in any Nationalized/commercial bank. The 50g Bronze Medal Plated with Gold should be prepared from the annual interest obtained on the deposit and should be awarded in annual convocation function.
- 4. The Medal shall be awarded to a student who stands first in evaluation based on the highest mark obtained in Genetics and Plant Breeding subject of Agriculture faculty.

 In the event of a tie, the awardee shall be selected based on the highest Overall Grade Point Average (OGPA) in B.Sc. (Hons.) Agriculture.
- 5. The prize shall be awarded in the form of a Medal engraved with the words "Dr. D. H. Chavda Gold Plated Bronze Medal".
- 6. A committee consisting of (a) Dean, Faculty of Agriculture, and (b) Director of Students' Welfare, shall decide the awardee for the Medal and the decision of the committee shall be final.
- 7. The Medal shall be awarded on the occasion of the Annual Convocation.
- 8. The endowment shall suitably be acknowledged by the Navsari Agricultural University on the occasion of the Annual Convocation.
- 9. The endowment shall suitably be incorporated in the annual report of the Navsari Agricultural University.
- 10. A student shall not be eligible for the award of Medal if he/she (i) Secures less than 7.5 grade point or secures 'F' (Fail) or 'US' (Unsatisfactory) or 'I' (Incomplete) grade at any time in any subject, (ii) has dropped (Barring withdrawal) any subject as regular student, (iii) left the subject incomplete or (iv) was punished under the 'Discipline Rules' by the College or placed under Conduct Probation by the college authority, or punished for use of "Unfair means" in the examination of Navsari Agricultural University till the end of final year examination.
