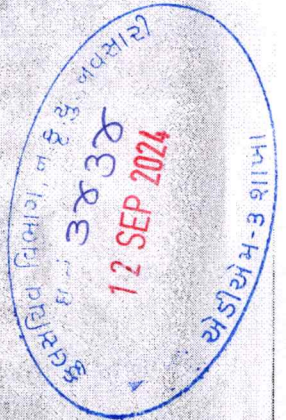

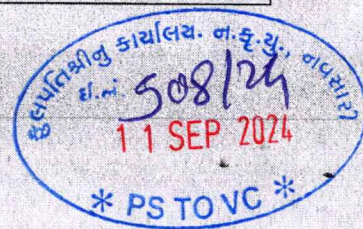

<b>Note 3 :</b>	Officers of only the Central or State Government or Union Territory Administration shall be eligible for absorption.






