Earnest Money Deposit: The tenderers have to submit EMD at the rate of 3 % of
price of item/s quoted ietms as mentioned in Annexure 1
The tender without Tender Fee and Earnest Money Deposit will not be considered.
Further, if submitted Tender Fee and Earnest Money Deposit amount is not matched
with quoted items, the tender will liable for rejection.
Refund of Earnest Money Deposit: The earnest money of unsuccessful tenderer will
be refunded. The Earnest Money Deposit of successful tenderer will also be
refunded after completion of purchase procedure.
Forfeiture of Earnest Money: The earnest money will be forfeited if tenderer
withdraws or modifies the offer after opening of tender document or tenderer does
not execute the agreement if any, prescribed within the specified time.
Security Deposit: Successful tenderer has to submit 5% of purchase order value as a
