Stage 1- Technical Bid Opening Stage

In Opening Technical bids were opened in presence of Committee members and was thoroughly checked and verified with their offline bids. Out of Six Parties one party (Sr. No. 2) was found ineligible in technical stage due to Income Tax return of Assessment Year 2019-20 was missing.

Five parties' bids were found eligible as per required Tender document. So five parties found eligible and qualified in Technical bids stage. The Committee has recommended to open Price Bid/Financial Bids of qualified parties in stage-2.
