This chapter shall be applicable from the date of issuance of Gujarat Civil Services (Revision of Pay) Rules, 2009</p> <p>Provided further that the provision of the Rules which was in existence prior to the issuance of the Gujarat Civil Services (Revision of Pay) Rules, 2009 Shall be applicable from the date of issuance of the COMMON STATUTE FOR AGRICULTURAL UNIVERSITIES OF GUJARAT (STATUTE NO. S.119.0) "State Agricultural Universities Services of Gujarat (General) Rules, 2011" till the date of issuance of Gujarat Civil Services (Revision of Pay) Rules, 2009 as amended from time to time.</p>

Consequent upon the introduction of revised pay structure under the Gujarat Civil Services (Revision of Pay) Rules, 2009 with effect from 1-1-2006, Government is pleased to decide that in modification of Government Resolution No. PGR/1098/36/M, dated 20<sup>th</sup> May, 1998 as amended from time to time, Transport Allowance to State Government employees shall be admissible at the following rates :-

2. The grant of Transport Allowance under these orders shall be regulated according to, and will be subject to the following conditions :-

- (i) The list of classification of cities/towns has been revised viz., A-1 to "X", A, A1, B1 & B2 to "Y", C and unclassified to "Z". The cities referred to as A1, A, B1 & B2 in these orders shall be the same as those classified as such for the purpose of Compensatory Local Allowance (CLA) as per Finance Department's Resolution No. VLB-102007-2016-CH, dated 16-05-2008. The term "Other places" may include any place where offices/formations of State Government are located.
- (ii) The Allowance shall not be admissible to those employees who are residing within a distance of one kilometer from the place of work or within a campus housing of the place of work and residence.

Note :- The grant of Transport Allowance would be subject to furnishing of a certificate by the Head of Department/Head of Office that the employee is not residing within one kilometer from the place of work or within a campus housing of the place of work and residence.

It is the personal responsibility of the Head of Department/Head of Office to verify such certificate.

- (iii) The Allowance shall not be admissible to those employees who have been provided with the facility of Government transport.
- (iv) In case of employees who have opted to draw pay in the pre-revised scales of pay, the Transport Allowance shall be regulated in accordance with the revised pay structure to which such employees would have been entitled to, had they opted to come over to revised pay structure.
- (v) In case of officers of the level of Secretary and above, who have been provided with the facility of office car for commuting between office and residence on prescribed payment basis under Government Resolution, General Administration Department No. AIS-3185-1468-G, dated the 27<sup>th</sup> June, 1995, as amended from time to time, an option may be given to them either to avail themselves of the existing facility or to switch over to the payment of Transport Allowance, as admissible under these orders. In case they opt for the latter, they may be paid the allowance at rates as applicable to them, subject to the condition that the existing facility of office car shall be withdrawn from the date they opt for the allowance. In case they opt for the former, the Allowance shall not be admissible to

them and they would not be required to make any payment for the facility of office car between residence and office.

- (vi) In terms of Government Resolution, Finance Department No.MSB-1278-86-J, dated the 5<sup>th</sup> January, 1979, as amended from time to time, conveyance allowance is admissible to such of the State Government employees borne on regular establishment (including work-charged staff) as are blind or are orthopaedically handicapped. Consequent upon coming into force of these orders, such conveyance allowance shall be abolished and instead all such employees may now be paid Transport Allowance at double the normal rates prescribed under these orders. In case, however, such handicapped employees have been provided with Government accommodation within a distance of one kilometer from the place of work or within a campus housing the place of work and residence, the allowance shall be admissible at normal (single) rates as applicable under these orders. The allowance shall not be admissible in case such employees who have been provided with the facility of Government Transport.
- (vii) This allowance will not be admissible during absence from duty exceeding 30 days due to leave, training, tour etc.
3. These orders shall take effect **from 1-4-2009**.
4. These orders shall apply mutatis-mutandis to Panchayat employees.
5. These orders shall apply mutatis-mutandis to the State Grant-in-Aid Institutions to whom Finance Department has sanctioned benefit of Fifth Pay Commission.

Consequent upon the introduction of revised pay structure under the Gujarat Civil Services (Revision of Pay) Rules, 2016 with effect from 01/01/2016, Government is pleased to decide that in modification of Government Resolution No.PGR-1009-77-Pay Cell (CH), dated 03/10/2012 as amended from time to time, Transport Allowance to State Government employees shall be admissible at the following rates:

1. The grant of Transport Allowance under these orders shall be regulated according to the conditions laid down in Finance Department G.R. No.PGR-1009-12- Pay Cell (M), dated 27/02/2009.
2. The orders regarding the classification of cities/towns/other places will be issued hereafter separately. The term "Other places" may include places where offices/formations of State Government are located.

3. For the purpose of implementation of this resolution, the term 'basic pay' shall mean the basic pay as defined in the Gujarat Civil Services (Revision of Pay) Rules, 2016.
4. These orders shall take effect **from 01/10/2022**.
5. These orders shall apply mutatis-mutandis to the Panchayat employees and the Grant-in-aid Institutions to whom Finance Department has sanctioned the benefit of revision of pay as per the Gujarat Civil Services (Revisions of Pay) Rules, 2016 and its employees are drawing Transport Allowance with the concurrence of Finance Department.
