Functions of the College-level Anti-Ragging Committee

Sr. Functions of the College-level Anti-Ragging Committee

No.

- 1 To arrange an orientation program for students.
- 2 To organize a joint sensitization program and counseling of both freshers and seniors by the professional counselor.
- 3 To arrange a joint orientation program for freshers and seniors, to be addressed by the principal and the anti-ragging committee.
- 4 To Send periodic reports of the action taken report to the university.
- 5 All teaching and non-teaching members of staff shall promptly report any case of ragging that comes to his/ her notice.
- 6 The college canteen and hostel mess are the places where ragging often takes place. The employers/employees of the canteens/ mess shall be given necessary instructions to keep strict vigil and to report any incidents of ragging to the college authorities.
- 7 In the first semester, each student shall be allotted to a student counselor (Faculty member) to keep track of the student's academic progress as a guardian. The allotted students shall meet the faculty from time to time, maybe every week, individually or in a group to sort out the problems/ difficulties faced by the freshers in the college/campus. The teacher shall make them feel at home which will enable them to report incidents of ragging or bullying. The teacher shall maintain a diary of the interactions with the student allotted to him.
- 8 Student counsellors in coordination with the Assistant Rector of the hostel shall make surprise visits to hostel rooms.
- 9 Freshers shall be lodged in a separate hostel block, if possible, where such facilities are not available, the college shall ensure that seniors' access to fresher's accommodation is strictly monitored by the Assistant Rector, security guards, and college staff.
- 10 If any incident of ragging comes to the notice of the authority concerned, the accused student will be allowed to explain and if his explanation is not satisfactory, the authority could expel him from the college and if found guilty he/she could be expelled from the university.
- 11 Any other appropriate steps for prevention of ragging.
