Terms & Conditions

- 1. Manufactures must submit certificate of registration as manufacturer along with quotation.
- 2. Authorized dealer / distributor of a company has to submit a copy of their dealership / distributorship certificate validated by the company for the current year along with company's price list. In case of a chain of dealership (Area dealer / sub dealer / local dealer), all the relevant Authorization certificates up to the end supplier has to be submitted along with their business registration details.
- 3. Rates supplied in a separate sealed envelope quoted should be inclusive of all applicable Taxes and F.O.R. our college at Navsari. As per notification wide no. 47/2017 dated 14 Nov, 2017and 10/2018 dated 25 Jan, 2018— Integrated tax (Rate) by Department of Revenue, Ministry of Finance (GOI), 5% GST is applicable for government funded institute.
- 4. In case of imported kits, suppliers will have to clear the consignment; will have to pay custom duty. Being an education institution Custom duty / excise duty exemption documents (Registration with DSIR and other related documents) will be provided. On request Hence, rates should be quoted keeping that in mind.
- 5. Should provide consumables with maximum possible discount (specify the amount of discount) of kits and that should be made clear at the time of quotation, if at all required.
- 6. Any offer of special discount after finalization of rate shall disqualify the party for the supply of goods.
- 7. The supply must be within delivery period mentioned in the order otherwise the consignment stands cancelled.
- 8. The manufacturers shall have to stick to their quality standards while supplying the goods. Goods supplied shall be rejected if found of inferior quality.
- 9. On scrutiny of tender documents, any queries raised by the committee have to be fulfilled satisfactorily with all documentary proofs within a period of 7 days.
- 10. The EMD will be forfeited if the supply of goods / material is not within stipulated time and of inferior quality as per the order.

- 11. The sealed tender super-scribed with "Fish Elisa Kits" shall reach to the office of the Principal, College of Fisheries Science, Navsari Agricultural University, Navsari 396 450 (Gujarat State) by RPAD / Speed Post / Courier on or before (office time) 01/02/2021.
- 12. All rights are reserved with the University Authority to accept or reject any or all the tenders received without assigning any reasons thereof.
- 13. The EMD (Earnest Money Deposit) will be 3% of the net quoted price (CIF/CIP value) in the form of DD shall have to be accompanied with the filled Tender Forms. Quotation without EMD and Xerox copy of tender fee receipt / DD for an amount of Rs. 1500/= (if downloaded from website) will not be considered.
- 14. Earnest Money Deposit (EMD) will be refunded to unsuccessful bidders after the deal is finalized. However, the same will be refunded to the successful bidder only after submitting required security deposit 5% of rated price for respective items.
- 15. The successful bidder has to deposit Security Deposit 5% of invoice value to the Fisheries college prior to the issue of purchase order by the University/Concerned department/College. This money will be remained deposited in University as the security deposit for one year and will be returned on demand if service is satisfactory. The security deposit in favor of " DDO ESTABLISHMENT OF COLLEGE OF FISHERIES N.A.U., NAVSARI " may be submitted in form of DD payable at Navsari.
- 16. Successful bidder has to perform purchase and supply agreement on stamp paper by paying stamp duty @ 4.90% of the security deposit.
- 17. In case of defective items, the same shall have to be replaced by the party concerned at its own cost, and risk and within stipulated time.
- 18. For all legal purpose court jurisdiction will be at Navsari, Gujarat.
- 19. Validity of the quotation shall be up to **31.12.2021**.
- 20. Payment shall be made only after satisfactory delivery of the items. No advance or part payment or payment through bank will be entertained.
- 21. The credentials of the party, list of customers and complete illustrated literature should be enclosed with the tender form. The firm should be ready for pre-inspection of the item and its performance, if necessary.
