Greetings from National Institute of Agricultural Extension Management (MANAGE).

As you are kindly aware that National Institute of Agricultural Extension Management (MANAGE), Hyderabad is an autonomous organization under the Ministry of Agriculture and Farmers Welfare, Govt. of India. MANAGE is mandated to carry out training, research, consultancy, policy advocacy, international programs, education, documentation and dissemination for strengthening Agricultural Extension systems in the country and implementation of Government of India's sponsored programmes.

Recognizing the role of MANAGE in strengthening Agricultural Extension systems in the country, Ministry of Agriculture and Farmers Welfare, Govt. of India has designated MANAGE as the Nodal Organization and Knowledge Repository for Bharatiya Prakritik Krishi Padhati (BPKP) specially focussing on Natural Farming. This announcement was made in continuation of the national address made by the Honourable Prime Minister Shri. Narendra Modi Ji on Natural Farming at Gujarat on 16th December, 2022.

Ministry has requested MANAGE to organize 750 Online Workshops to create awareness to all Gram Pradhans on Natural Farming across the country from 1st April, 2022 to 15th August, 2022 as part of Azadi Ka Amrit Mahotsava. In view of this, MANAGE proposed to create a large pool of Master Trainers by selecting and training the officials who are interested to conduct Awareness Programmes to Gram Pradhans across the country. Hence, MANAGE

proposed to conduct few batches of Five Days Online Programmes on Natural Farming for those who are interested in Natural Farming and involving in this mass awareness campaign programme. After the training programme, the expertise of the Master Trainers will be utilized for conducting online awareness programme across the country by providing suitable honorarium as per the scheme guidelines.

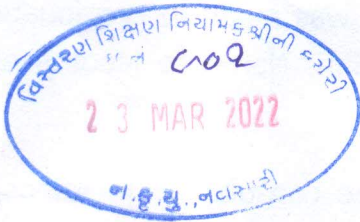
